The **ELIGIBILITY** for election is pursuant to the Malaysian Dental Association Constitution Article 7 Section 2(d) and (e) which reads as follows :

- d) Only persons who have served **two (2)** complete terms in the Council, not necessarily consecutively, shall be eligible for the nomination for President-Elect.*
- e) Only members in benefit and present at the Annual General Meeting or those who have given prior written consent to the Honorary General Secretary are eligible for Election. (Members in benefit are defined here as members whose subscription for the current year has been paid at the time of nomination).*

The Nomination Form must be duly filled and signed by the candidate, the proposer and the seconder who shall be MDA Ordinary members in benefit (inclusive of Life members) with membership subscription fully paid up to 2021.
